### Membership:

  - O If the weekend of April 9<sup>th</sup> and 10<sup>th</sup> is selected, this needs to be quickly to Mary Kay Rushman, as she will be setting up the lecturers and minister schedule for that weekend in the next couple of weeks.

### Church:

- Holy Week Schedule:

  - o Good Friday: Adoration of the Cross at 3 PM

- Our Council needs to hold a 1<sup>st</sup> degree...will try to set it up for 6 PM on Palm Sunday
  - o Dan will contact Mitch Michaelis and GK will contact James Gunter
- Catholic Men's Conference is this weekend (bus from Blythewood didn't have enough interest so they are going to car pool).
- Will try to schedule the next pancake breakfast on April 3<sup>rd</sup> for St. Vincent de Paul

- o Still have bacon and sausage left over from Shrove Tuesday
- Also need a pro-life breakfast in May
- GK got through to Centerplate today and has an appointment with them next Wednesday.
  - If we are going to work the football concession stands again, we need to enroll in direct deposit,
     which Centerplate just started
  - We raised \$1,400 this year and spent 350 on parking, so we only netted about \$1,000 over 6 games
- Other fundraising ideas:
  - o The District Deputy suggested that spaghetti dinners are cheap and make a lot of money.
  - o The Blythewood Council, Council 724, and the Orangeburg Council hold fish fry's.
  - o We can set up a Pay Pal account to take membership dues and link to it from the Council website.
  - We can donate to a charity with every Amazon purchase, and we need to get our council set up for that.
- Holy Family Icon arrives on Saturday 3/5
  - Normally, Churches have a program and put the Icon on display. The Icon needs to be on display in a place of reverence.
  - o Another Icon, a Fatima statue, will be coming to St. Joseph on 5/13.
  - o Blythewood has the Holy Family Icon from April 2-8.
  - We can have the Holy Family Icon any time before Blythewood, but since it is probably too late to do anything with this...we will pass on accepting the Icon.

## The District Deputy reported as follows:

- Congratulations on qualifying for star council...1<sup>st</sup> in district and now Blythewood has qualified as well.
- Reminder that along with SB7 form, we need to submit a form for the ICC awards
  - o We probably qualify for a distinguished council award (this is a non-competitive award)
  - o Church service award is also available.
  - Competitive awards also exist.
- On Saturday April 30<sup>th</sup>, the Knights have been giving the honor of volunteering for a Habitat for Humanity house in West Columbia. Brother Knights will have to register online to volunteer.
  - o Someone donated money to name the house in honor of Pope Francis.
  - o District Deputy will forward information on registering when he gets it.
- St. Vincent de Paul has been organizing a "House in a Box" program.
  - o They are trying to raise enough money to assist 300 families in the area affected by the flood last fall.
  - Using \$1,850 in donations, they try to provide a family with everything insurance doesn't cover (i.e. Furniture, clothing, etc....)
  - o They are trying to raise 350,000 for the project.
  - o Marylyn Gray from St. Peters, the coordinator of the project, is willing to talk at council events to promote the program.
- \$12,000 was provided by the Supreme Council to help with the floods. The money was given to Harvest Hope and St, Vincent de Paul.
- The state now has a Knights of Columbus disaster coordinator.
- Each Council should have a 3 member disaster team.
- The State Convention is on the 22<sup>nd</sup>
  - o Council needs to fill out a form to submit delegate information this week.
  - o Registration forms also need to be filled out.
