# The Most Holy Body and Blood of Christ

The Most Holy Body and Blood of Christ with some research on our most sacred belief in the Real Presence of Jesus Christ, body, blood, soul, and divinity residing in the Holy Eucharist

According to Gregory A. Smith, Associate Director at the Pew Research Center, just one-third of U.S. Catholics agree with their church that Eucharist is body, blood of Christ.

Transubstantiation — the idea that during Mass, the bread and wine used for Communion become the body and blood of Jesus Christ — is central to the Catholic faith. Indeed, the Catholic Church teaches that "the Eucharist is 'the source and summit of the Christian life.'"

But a new Pew Research Center survey finds that most self-described Catholics don't believe this core teaching. In fact, nearly seven-in-ten Catholics (69%) say they personally believe that during Catholic Mass, the bread and wine used in Communion "are symbols of the body and blood of Jesus Christ." Just one-third of U.S. Catholics (31%) say they believe that "during Catholic Mass, the bread and wine actually become the body and blood of Jesus."

Seven-in-ten U.S. Catholics believe bread, wine used in Communion are symbolic.

In addition to asking Catholics what they believe about the Eucharist, the new survey also included a question that tested whether Catholics know what the church teaches on the subject. Most Catholics who believe that the bread and wine are symbolic do not know that the church holds that transubstantiation occurs. Overall, 43% of Catholics believe that the bread and wine are symbolic and also that this reflects the position of the church. Still, one-in-five Catholics (22%) reject the idea of transubstantiation, even though they know about the church's teaching.

The vast majority of those who believe that the bread and wine actually become the

body and blood of Christ — 28% of all Catholics — do know that this is what the church teaches. A small share of Catholics (3%) profess to believe in the real presence of Christ in the Eucharist despite not knowing the church's teaching on transubstantiation.

About six-in-ten (63%) of the most observant Catholics — those who attend Mass at least once a week — accept the church's teaching about transubstantiation. Still, even among this most observant group of Catholics, roughly one-third (37%) don't believe that the Communion bread and wine actually become the body and blood of Christ (including 23% who don't know the church's teaching and 14% who know the church's teaching but don't believe it). And among Catholics who do not attend Mass weekly, large majorities say they believe the bread and wine are symbolic and do not actually become the body and blood of Jesus.

The survey also finds that belief in the real presence of Christ in the Eucharist is most common among older Catholics, though majorities in every age group (including 61% of those age 60 and over) believe that the bread and wine are symbols, not the actual body and blood of Christ.

Now here's a meditation from the Magnificat for June 14<sup>th</sup> - the Feast of Corpus Christie, the Body of Christ, which we receive every time we receive Holy Communion. The meditation is entitled, "The Most Holy Body and Blood of Christ."

Oh Jesus! My Lord, my God, and my all! I believe that you in your living manhood are as truly present in the Blessed Sacrament as when you did walk amidst men and converse with them. Relying on their word, which shall not pass away, I believe that you are here ever living to make intercession for us. Here is you sacred Body, which hung upon the cross; her is your is your soul, which was sorrowful unto death and agonized in the Garden of Olives on account of my sins; here are those sacred wounds make by the nails and appear; here are those eyes which looked with pity and love on the penitent Peter; here are those ears which heard the cruel cry ... crucify him, and which listened so compassionately to all the ills of men. I do believe, Lord' help my unbelief.

Throughout the centuries sacred writers have vied with one another in describing the marvel of the Real Presence. It has been called the greatest work of God, the mirror of the divine perfections, the reflection of the wisdom, the immensity, and the eternity of God, a type of all the operations of God, the teacher of the unity of God, It has been described as the continuation and the parallel of the Incarnation and the sum of all its wonders, as the mirror of the life of Christ, as the triumph of the Church and even as its very life, as the explanation of the phenomena of the Church as the compendium of all miracles, as the example of every virtue, as the fountain of all grace, as the magnet of souls. Yet, strive as they may, no writers, no poets, no saints can say anything more outstanding than this truth - the Blessed Sacrament is God.
