Unfinished business was taken up and disposed as follows:

• Fr. Williams has a Bible study after Mass on Sundays which is very popular. On 9/12, our council will be providing BBQ as well as sides to be purchased by the council. We will cook the butts on Saturday. We will meet in the church kitchen at 3:00PM and will travel to USC, set up, and serve the meal after the 5:30PM Mass. Volunteers welcome for cooking help on Saturday.

New business was taken up and disposed as follows:

- Christmas tree sales: Robb has located a provider for Christmas trees in Banner Elk, NC. Robb would like to resume the Christmas tree sales this year. Details will be provided and a vote taken at the September meeting.
- Robb is working on a budget and will present it at the September meeting.
- We would like to do another event like the previous wine and cheese event on 10/14, to offer beer this time. There will be an Octoberfest Beer Garden theme. There will be a Wurst wagon to provide food and a souvenir glass. This is expected to be a good fundraiser. Robb would like to discuss which charity we'd like to support at the September meeting. We will not be partnering with other organizations this year. The parish will help with some of the food. We hope that this activity will help parishioners become involved again.
- We intend to do Columbus Hope again this year. A chairman is needed.
- There will be a ministries fair in November, with food trucks, games, etc. Date to be provided and our council will provide some help.
- There won't be a parish picnic this year a variety of events for parishioners is planned instead. Our council will be helping with many of these events.
- There will be a Mass of Remembrance; we will provide the wine. It will be in the first week of November exact date to be provided.
- We will include in the budget the costs of providing sacramental cards, at least for Baptisms. This is to help make us visible to families in the parish and to serve our parishioners. We will discuss this at the next meeting.
