The Minutes of the previous meeting: The motion was made proposed to change the date from 2021 to 2022, the approval of the Minutes for March business meeting was moved, seconded and approved.

Adoration in the Gym till 9:00 p.m. Stations and devine novena at Noon. 3:00 pm is the reading of the passion. Holy Saturday - Easter Vigil mass - 8:00 p.m. we will have the Easter fire. Sunday is under the usual schedule and there will be a live stream at the Gym. Office is closed on Easter Monday. Devine mercy Sunday, 2:00 p.m. is the conclusion of the Devine novena.

Membership Report: One new member. We are waiting on two other potential members to be nominated and then we will hold a ceremony for the new members. The new members are Martin Kaminski and Patrick Hayes. Motions were made and seconded to approve their membership and the motions passed. We have four other possible candideates. Andreus Knasas has submitted his form but we still need to interview. We are still reacing out to the other three. The GK recommended that we use the opportunity to do the virtual ceremony.
