

Saint of the Month by Deacon Charles P. Poole, Jr.



St. Gregory VII

Feast day May 25

Life: 1021-1085

Pontificate: 1073-1085

Gregory was born in Tuscany, Italy, and bap-

tized Hildebrand. Early in his life He spent some time at the famous monastery of Cluny where he may or may not have become a monk. For almost 30 years he served five successive popes as secretary performing many tasks. For example, when Berengar of Tours was denying the Real Presence of Jesus in the Eucharist Hildebrand was sent to France in 1055 to combat this heresy. Two years later he was appointed the papal legate to Germany, and in another two years he was became an archdeacon.

During his time there were many abuses present in the Church, such as simony or making a profit from sacred things, and Nicolaitism or clerical marriage and irregular unions. Another abuse was hereditary benefices, or ecclesiastical positions which involved fixed income or property that were passed on to heirs. Perhaps the worst abuse was the system of investiture whereby church officials were appointed by laymen and the pastoral staff, or symbol of the church office was conferred by

the civil ruler instead of by the bishop. These abuses were remedied by what has become known as the **Gregorian Reform**, the reassertion of papal supremacy over civil rulers, and the ending of their control over Church affairs. His reforms were justified as a return to ancient practices of the Church. Gregory forbad simony, reestablished the celibacy of the clergy, and ended lay investiture. He is well known for the event when the excommunicated Emperor Henry IV traveled to Canossa to beg for pardon and was kept waiting for a long time in the bitter cold snow. Gregory believed that the Pope and the Church were supreme over civil rulers throughout the world, and could dispose of them at will.

The Gregorian reforms were made official by the documents *Dictatus papae* and *Libertas ecclesiae*. Gregory had to fight against much opposition for the establishment of his reforms.

Toward the end of his life Henry revived the conflict, claimed to depose Gregory and to replace him by Antipope Clement III. Norman troops took over Rome, and Gregory retired to Monte Casino. On his death bed his famous last words were "I have loved justice and hated iniquity, that is why I die in exile."

Renew Your Vows and Your Marriage

Men, are you taking your wife for granted? Let me take care of that nonsense right now. I have buddies whose brides died of cancer. A while back I received a call from my friend Billy about his wife, whom he has loved since they met back in college. He said, "Carey, she's sick. She's really in trouble." And he broke down and cried.

Men who have lost their wives would give anything to go back and do things just a little better. Maybe they'd change their priorities, or make better use of the time they do have. Men who have been through a divorce often have similar feelings.

Sometimes you hear about couples renewing their marriage vows, and I think that's a useful idea whether it's a formal ceremony or just an inner recommitment "from this day forward, 'til death do us part."

And what about that line, "in sickness and in health"? I don't think the bride and groom fully appreciate what they're saying. What if the marriage ceremony actually listed some of the possible challenges, sicknesses and tragedies? What if one of the spouses will get cancer, be paralyzed, or have mental problems? Maybe they'll have a miscarriage or two.

Tragedy almost always takes us by surprise. And suddenly we've forgotten the vows made many years ago, or we never realized what the vows mean in the first place.

I think about these kinds of challenges, and I thank God for my bride, Melanie. She's such a blessing to me, and I try to serve her in small ways every day —getting her something from the kitchen, or washing the dishes, or carrying dirty clothes down the stairs, or just making the bed. You could probably list a hundred ways to serve your bride — from arranging a second honeymoon to just putting down the toilet seat. It all adds up.

Let me confess, when I invest in Melanie, I'm getting something in return. She's an extension of me wherever I go. She gives me great feedback and encouragement on all the things I do. She makes me a better dad. She loves me through my brokenness and weaknesses. And that makes me love her even more.

Dad, even if it doesn't always feel like it, your marriage is a great gift from God. I hope you'll renew your commitment to those vows you made to your bride.

SC State Convention – RECAP

The 90th Annual SC Knight of Columbus State Convention was held April 30-May 1 in Myrtle Beach, SC. Special guests included Daniel J. Baker from the Supreme Board of Directors, and Honoree Joe Gubeli, Immediate past State Deputy and District Master. Representing St. Joseph Council 12554 were GK Skip Hudson, DGK Fred Parsons, and Recorder Pro-Tempore Troy Penny.

Saturday - Opening Session

State Deputy Tom Monahan opened the session with a welcome, a brief recap of the cumulative successes of the KOC in SC during 2011, and a directive that we need 88 more members state-wide to attain our fifth straight Circle of Honor this year. This includes a mandate for every council to bring in at least 2 new members by the end of June.

Tom Monahan announced the implementation of a new 3rd Degree ceremony that is a significant change to the ceremony we have used for the last 30 years. The new 3rd Degree goes into effect on May 1, 2011. South Carolina will first perform the new 3rd Degree in Conway on July 16, 2011. 3rd and 4th degree knights are encouraged to make plans to attend one of the new format ceremonies this year.

Father Robert Higgins, State Chaplain reviewed the recruitment letter from Bishop Robert and emphasized how unprecedented it was for the KofC to receive such a strong recommendation from an Apostolic Vicar. Fr. Higgins stressed that the Church needed the Knight of Columbus, particularly as it is challenged with falling numbers in the priesthood.

Father Higgins pointed out that while we have always been good at raising money, there should more

to the KofC than Charity work. He reminded all that "Faith in Action" has an evangelistic meaning and that we must be more pronounced in our active Catholicism as the "face of the church" to the community. This may mean being more selective in who we pursue as members to ensure we aren't just getting bodies, but genuine practicing Catholics.

Daniel Baker, Supreme Director gave a brief talk on the Knight's nationwide successes in fund raising and applauded SC for its contributions. The Knights now have 1.8 million members world-wide. SC is the first and only state to place 5 ultra sound machines.

Saturday - Afternoon Session

Roll-call indicated that 44 councils were in attendance (about 160 delegates and alternates). For the first time SC will have no councils under suspension or probation.

Nomination committee presented candidates for State Offices and Delegates to Supreme Convention. All were elected unanimously without dissent or debate.

12 resolutions of support or appreciation were read and adopted unanimously. There were no legislative resolutions on the table.

New Business was minimal – A recommendation was introduced by Council 13713, Blythewood, that the RSVP be expanded to include Deacons in training. This proposal was tabled for consideration at next year's convention.

Budget for year 2011-2012 was presented by the State Treasurer in the amount of \$89,125, which was approved unanimously. This is an increase of \$2,325 over the previous fiscal year's budget.

The 91st State Council Convention will be held in Columbia in late April or early May of 2012, and will be hosted by the Districts and Councils of the Midlands.

Sunday Session

Presentations were given on the "Shadow Children" of Georgetown and the work that the Knights are doing to clothe the children of that county, a pre-recorded message from Supreme Knight Carl Anderson, and also on the Beatification of Pope John Paul II.

State Awards winners were announced.

St. Joseph Council 12554 was recognized with a plaque for completing 115% of our Operation HOPE goal for 2010. Congratulations to Co-Chairmen Jack Davis, Sam Kopack, and to all of our Brother Knights who contributed their time and sweat to this worthy cause!

St. Joseph Council 12554 was awarded with "Distinguished Council" for the current fraternal year, the highest non-competitive award given by State Council. Congratulations to Program Director Dan Wagner, ICC Chairman Sam Kopack, each of our Activity Directors and Chairmen, and to every Brother Knight who worked tirelessly to make this fraternal year a success!

Alabama Requests Tornado Relief Assistance

The following is a letter sent from State Deputy Ray Carney of the Alabama State Council to our State Deputy, Tom Monahon. This letter is a request and an invitation for our help. They do, of course, need financial and donations of goods (food, water, clothing, toiletries, etc) but this letter has a specific request. Those in charge of relief efforts have exhausted their storage space for donated goods. State Deputy Carney requests the donation or loan of trailers or other portable storage containers to assist the relief efforts.

My Worthy Brother State Deputies,

I am sure that you are aware of the tornado's that occurred in Alabama and other Southern states last Thursday, April 28th, and of the vast destruction and deaths that were caused by this F5 Tornado. Evaluating the situation and devising a plan of action takes time. Living on the Gulf coast and seeing the destruction that results from hurricanes, I feel that I am somewhat familiar with the recovery process, even though this is my first year as State Deputy.

Our State Convention was scheduled for this past weekend, so when the news came of the destruction of the tornados, we were not sure if the Convention could go on as scheduled. After calling the hotel where the convention was to be held, we found that all was well there, so the convention went on as planned. We all witnessed the Holy Spirit was at work this weekend, even in our darkest hour, His light shines through!

When I returned home last evening, I was in contact with Theresa Petruzella, whom Bishop Baker appointed to head up the Tornado Disaster Relief (Bishop Baker is in Birmingham, and Tuscaloosa and all of north Alabama is in his Diocese). Theresa and I have started working on a plan, which includes any and all help that the Knights can give. Foremost, Bishop Baker wants the Knights to "fly their colors" by wearing their shirts, hats and using banners. He wants the word "Catholic" on the shirts and banners, as Tuscaloosa is located in the Baptist Belt of Alabama, and many don't know who the Knights of Columbus are. I have ordered new materials to address this concern.

I have directed my Knights to get in touch with their Pastors, Schools and Convents so that the kitchens can be opened up and we can start feeding the flock. Now comes a special request from Theresa: The most needed thing right now is warehouse space. They are receiving clothing, non-perishable food items, baby needs, water, etc., but they have no where to store these items. If any of our Brother Knights have any containers or tractor-trailers that they may not need for at least a year, Alabama can use them. Sister Carol Grace, head of Catholic Social Services in Tuscaloosa, has 17 acres available on which to store the containers or trailers. This is an immediate need! Please use your e-mail list to get this call out, we never know who may have a contact to supply this need.

As with all disasters, financial help is always needed. The destruction is not just in Tuscaloosa, but also many small towns across north Alabama (Continued on page 11)

and other Southern states. We have set up a Tornado Disaster Relief Account in Alabama, and our Worthy State Treasurer, Pete Parrish will handle these funds. His address is PO Box 678, Jasper, AL 35502-0678. His phone number is 205-295-3100.

My Brother Knights, the need is great. Please keep Alabama and the other Southern states that have been affected in your prayers. As of this morning, there are still 500 people missing in the Tuscaloosa area alone. I can't even begin to imagine the emotional and physical distress that the people of Tuscaloosa are feeling.

Alabama thanks you for any and all help that you may be able to provide!
